Subj: SMOKING IN MARINE CORPS OCCUPIED BUILDINGS AND FACILITIES

1. Purpose. To provide policy and guidance for the smoking program in Marine Corps occupied buildings and facilities in compliance with the references.

2. Cancellation. GruO 6200.1A.

3. Background

a. The Marine Corps recognizes the right of individuals working or visiting Marine Corps occupied buildings to an environment reasonably free of contaminants. The Surgeon General of the United States has determined that the smoking of tobacco is the most preventable cause of illness and death. Medical evidence shows overwhelmingly, that tobacco use impairs cardio-respiratory endurance, exercise tolerance, and stamina.

b. Troop information lectures and discussions and other similar educational programs should be utilized for imparting the latest information on smoking and the most recent medical research and other educational material.

4. Action. The Marine Aviation Training Support Group (MATSG) smoking program shall be controlled in accordance with the following guidelines:

a. Those areas designated as smoking area are to have signs posted such as "DESIGNATED SMOKING AREA". For example, areas outside of buildings (i.e., courtyards, terraces, etc.) will be the only location for smoking for those Marines desiring to smoke.

b. The following areas are not to be designated as smoking areas: Inside the confines of any building aboard NAS Lemoore, (work spaces and barracks).
